- ALL Academy lessons purchased in packages run RAIN OR SHINE except in the most severe weather situations. If you haven't heard that lessons are cancelled directly from your trainer, assume that lessons are still being held. Horsemanship lessons will be given whenever riding isn't possible. Individually purchased academy lessons may be rescheduled to another day in the month in which they were purchased if approved by the trainer and notification is given at least 48 hours in advance OR a doctor's note is provided for illness.
- There are no make-up lessons or credits available for missed lessons when purchasing academy lesson packages for any reason (As of 8/1/2022). Any variation from this is SOLELY at the discretion of the trainer. Owners and full-leasers may purchase individual lessons at the beginning of each month for \$50 per lesson (\$60 for haul-in lessons,) and make-ups/credits/training rides will be provided for missed lessons. <u>Deductions should not be made from due payments for lessons that will be missed payments are for a spot in the program, not based on attendance.</u>
- Lesson Packages may be paid for at the beginning of the semester (Feb 1), in two equal payments (Feb 1 & Mar 1), or at the beginning of each month of the semester. A fee schedule is on the next page for your review. A \$25 late fee will apply to any payments made after the due date, with a \$10 per day fee added on top starting on the 3rd of the month.
- A **30-day notice is required** before a rider <u>stops or reduces lessons</u> so that a replacement rider from the waiting list may be notified to fill their lesson spot.
